Explanation Addendum to Seller Disclosure Statement for 181 Empire Creek Road, Malo, WA

1.E. There is a path off the driveway that the neighbors occasionally use to access their property. They previously asked, and were granted, permission to use the path. To our knowledge, they haven't used it in about a year. It was never used on a frequent basis.

1.G. Many years ago, some government agency (WDFW?) did an overhead (plane or satellite) study and determined that a dry, shallow "draw" on the property could contain flowing water at some point (though it never has to our knowledge) and therefore could result in land use restrictions near the draw. We believe the draw was east of the house. We are not sure exactly where, whether any restrictions took affect or were appealed, or whether it has any bearing today.

1.J. Yes, the boundary of the property was surveyed before construction.

2.C.2. An irrigation zone on the west side of the house and a zone in the most distant area of the back yard may not be working correctly. Additionally, there are two water tanks that service the irrigation system, only one of which is operational at this time. The 2nd tank previously provided extra storage capacity for the irrigation system. This tank was found to be losing water and was closed off a couple of years ago. We think the problem may be with a fitting to the tank rather than the tank itself. The irrigation system has been running fine without the 2nd tank, but just can't run as long at any one time. Even without the 2nd tank, the irrigation system can be run for many hours. The tank issue does not impact house water at all.

3.D.4. The septic system may have been inspected when it was pumped by Stotts in 2023. To our knowledge the septic system is working normally.

4.B. When a water pipe "T" cracked outside about two years ago, a small amount of water seeped into the basement via conduit access points. The "T" has been replaced.

4.F.

- Doors – The two exterior doors in the living room area have a small area of rot in the exterior door casement. The Seller intends to fix this.
- Wood stove – The wood stove door handle is loose; there is a workaround that allows the wood stove to be actively used.
- Outbuildings – The well house building has a wood ant infestation.

4.H. The well house building has a wood ant infestation.

4.I. There is no attic because it is an A-frame, but the roof is well insulated.

5.A. There are two gas furnaces. The furnace below the kitchen has not been consistently working, and the furnace below the living room area circulates exhaust fumes from the garage into the living room. A repair person has been contacted to address both issues. There is no cooling system in the house.

5.C. In addition to the wood stove, there is also a wood furnace that can serve as a backup to the gas furnaces. The wood furnace was tried and found to work when first installed but hasn't been used since.

5.G. The Sellers have internet service via Hughes satellite dish. There are no fiber optics to the property.

7.D. There is a creek on the property. See also the explanation for 1.G. above.

7.E. There is an above-ground propane tank, an above-ground diesel tank, and two in-ground gas tanks in a vault. To our knowledge, none of the fuel tanks have ever leaked.

7.F. The property was previously a logging site.
