





1.G. Many years ago, some government agency (WDFW?) did an overhead (plane or satellite) study of the area and determined that a dry, shallow "draw" on the property could contain flowing water at some point, though it never has to our knowledge. This could potentially result in land use restrictions near the draw. We no longer recall whether any restrictions took effect or were appealed, and don't know whether it has any bearing today. We believe the draw was east of the improved portion of the property.

2.C.2. An irrigation zone on the west side of the house and a zone in the most distant area of the backyard may not be working correctly. Additionally, there are two water tanks that service the irrigation system, only one of which is operational at this time. This tank was found to be losing water a couple of years ago. We think the problem may be with a fitting to the tank rather than the tank itself. The irrigation system has been running fine without the 2nd tank, but just can't run as long at any one time. Even without the 2nd tank, the irrigation system can be run for many hours at a time.

4.B. When a water pipe "T" cracked outside about 2 years ago, a small amount of water seeped into the basement via the conduit access point. The "T" has been replaced.

4.F. The wood stove door handle is loose, but there is a workaround that allows the wood stove to be actively used. The well house building has had a wood ant infestation.

4.I. The well house building has had a wood ant infestation.

5.C. In addition to the wood stove, there is also a wood furnace that can serve as a backup to the gas furnaces. The wood furnace was tried and found to work when first installed but hasn't been used since.

7.D. There is a creek on the property.

7.E. There is an above-ground propane tank, an above-ground diesel tank, and two in-ground gas tanks in a vault. To our knowledge, none of the fuel tanks have ever leaked. The house has a radon gas collection and ventilation system just in case it's needed; we are not aware that radon actually exists.

7.F. The property was previously a logging site.
