DECLARATION OF COVENANT

KNOW ALL MEN BY THESE PRESENT, that we, GORDON NELSON and JOYCE NELSON, husband and wife, owners in fee simple of the land described herein, hereby declare this covenant and place of same on record to the public.

NOW, THEREFORE, the grantors agree and covenant that said Grantors, their heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the Grantors and within 100 feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as cesspools, sewers, privies, septic tanks, drainfields, manure piles, garbage of any kind or description, barns, chicken houses, rabbit hutches, pigpens, or other enclosures or structures for the keeping or maintenance of fowls or animals, or storage of liquid or dry chemicals, herbicides, or insecticides.

These covenants shall run with the land and shall be binding on all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
