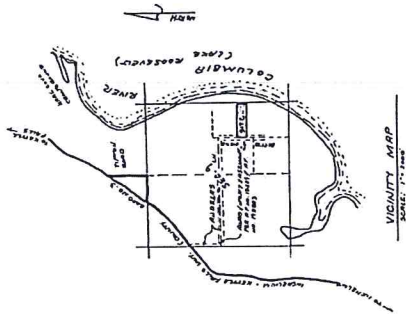

2. REAL PROPERTY LOCATED WITHIN FARMER COUNTY MAY BE SUBJECT TO STATE, LOCAL, AND TRIBAL REGULATION CONCERNING WILDLIFE, CULTURES, GEOLOGICAL, PLANT/ANIMAL AND OTHER CRITICAL AREAS.
